

<b>Minutes of Meeting of Mullingar Municipal District held on Monday, 12<sup>th</sup> June, 2017, at 2.00pm, immediately following the Annual Meeting, in the Council Chambers, Áras an Chontae, Mullingar.</b>

At the outset, the newly elected Mayor welcomed all to the June Monthly Meeting. Cllr.Glynn asked for Standing Orders to be suspended to allow Members pay tribute to Cllr.Avril Whitney who had recently resigned from Westmeath County Council membership. This request was allowed.

Members paid glowing tributes to Avril Whitney, who recently made the decision to resign from the membership of Mullingar Municipal District and Westmeath County Council due to work and personal commitments. Members stated that Avril was a committed member of the Council who was enthusiastic and articulate and carried out her duties as a representative of the Council very well. They also praised her work on the Longford Westmeath Education and Training Board where she served as Cathaoirleach. The Director of Services also wished Avril well in her career in the future and stated that an official letter has already issued to Avril from the Council’s Executive.

As Standing Orders were still suspended, the Mayor then allowed Cllr.Penrose to speak about difficulties experienced by people in Ballynacargy and Moyvore over the past weekend due to a number of water bursts. He thanked Westmeath County Council for all their assistance in repairing the burst watermain and asked what arrangements are in place by Irish Water for such occurrences, particularly in the area of emergency stand by crews. Other Members joined with Cllr.Penrose in voicing their concerns at the lack of water over the weekend and the ensuing problems.

The Director clarified that a part which was needed to fix the burst pipe had to be sourced and this led to the delay, particularly as it was not a standard sized pipe. He stated that once sourced and delivered from Dublin, the repairs were made as soon as possible and he stated that additional replacement parts have also been stored should such a situation arise in the future. The Director also advised that proposals for out of hours staffing arrangements are being considered at present by the relevant Unions.

**Item 1 : Miontuairisci**

- (i) On the proposal of Cllr.Glynn, seconded by Cllr.McDermott, the Minutes of May Meeting of Mullingar Municipal District held at 2.00pm on Monday, 8<sup>th</sup> May, 2017 in the Canteen, St.Joseph's Secondary School, Rochfortbridge were unanimously approved.

**Matters arising:**

Cllr.Glynn referred to the situation discussed at May Meeting where stones were being thrown from the Iarnrod Eireann bridge onto passing cars. He advised that a car in the adjacent Council carpark had also been damaged and he asked for an update on this matter. The Director advised that following a letter to Iarnrod Eireann, Iarnrod Eireann have provided the name of a contact person and this person will now be contacted.

Cllr.D'Arcy referred to the situation where large lorries are using the mouth of a housing estate in Delvin to turn and asked if there is an update or a solution to this issue. The Director advised that he would like to give more time to the operator of the business whose trucks are involved, to find a permanent solution. Cllr.D'Arcy agreed to this.

**Item 2 : Update on issues raised by Public Participation Network**

Ms.Anne Drury made observations on the replies provided by the District in the document prepared by the PPN. The Director updated the Members and the members of the PPN and stated that the issues raised are also often raised by the Members of the Municipal District during the year. Furthermore, he stated that a lot of the items listed are costly and would have to compete at Budget time with other areas for very limited funding. Following the presentation, the Members of the PPN then left the Meeting.

**Item 3 : Update on Urban Regeneration Project for Mullingar.**

The Members were presented with drawings of the proposals for the centre of Mullingar Town and the consultants updated Members and responded to their queries regarding the Urban Regeneration plans for the town. The Members were supportive of the proposals, however concerns were raised about parking, and how traders might be affected by the works and also the proposal to provide a pedestrian area on part of Mount Street. The Director reassured the Members that all concerns and observations can be dealt with as part of the Part 8 planning process.

On the proposal of Cllr.McDermott, seconded by Cllr.Clarke, the Members unanimously agreed to commence the Part 8 planning process for the Urban Regeneration Project for Mullingar.

At this stage, the Mayor advised Members he would take Item 6 on the Agenda.

**Item 6 : Community led mural in Mullingar Town.**

Ms.Miriam Mulrennan, Arts Officer, gave a presentation to Members on a community led mural which will be provided on a wall in Blackhall carpark, and which tells the history of Mullingar in pictures, reflecting themes of local history and myth. She stated the project will conclude at end of July.

***Item 4 : Municipal District Litter Management Plan***

Leo Buckley, Executive Engineer, gave a presentation to Members on the Litter Management Plan 2017-2019. He outlined the steps being taken by the local authority in the fight against litter, including education and awareness, statistics, a review of the past Litter Management Plan 2014-2016 and objectives for the implementation of proposals for the District.

The Members raised the issues of dog fouling and fly tipping and while acknowledging that the Council is doing as much as it can in these areas that until the law is changed, these issues will continue, because legislation to bring perpetrators to court is not strong enough.

The Director stated that through the Environment SPC, a lot of work has gone in to the preparation of this Litter Management Plan 2017-2019. Referring to dog fouling and the section of the Plan relating to this issue, he stated that it is only through education and public awareness that the public can be made aware of their responsibility in this regard. The section also outlines the penalties which apply.

On the proposal of Cllr.Hill, seconded by Cllr.Clarke, the Municipal District Litter Plan 2017-2019 was unanimously approved.

It was agreed to adjourn Item 5 to the July MMD Meeting.

***Item 7 : Update on SEAI funded public lighting in Mullingar.***

Corinna Elder, Executive Engineer, gave a presentation to Members on a new phase of funding provided by the Sustainable Energy Authority of Ireland to fund the replacement of a total of 253 public lights at Pettitswood and at Grange to LED lights, as well as replacement of some lights in the Athlone Municipal District. The grant for this work is being provided under the heading of Better Energy Communities and will make a difference to the efficiency of paying for public lighting in the District. She stated the rollout of the new lights will be in two phases, below the ground and above the ground and this project is concerned with replacement of the lanterns only.

The Members welcomed the proposal and the fact that these new lights will be paid for out of a grant provided by SEAI.

The Mayor agreed to adjourn Item 8 and Item 9 to the July Meeting.

The Members then adjourned for a tea break.

***Item 10 : To consider and approve Community Grants – Tidy Towns Grants, Residents Association Grants and Community Action Grants.***

The Director updated the Members on the Community Grants, stating that the sum of €190,000 has been provided in 2017 for Community Grants and Cathaoirleach Awards. The sum agreed for community grants was €136,000 and this funding supports and encourages community groups with local voluntary work. He circulated lists of the various grants awarded, advising that all applications were assessed by an evaluation committee based on the criteria for the grants. Members noted and approved the Community Grants for 2017.

***Item 11 : Festival and Events Grants***

The Members were circulated with a list of grants awarded under the second tranche of the Festival and Events Grants 2017. These run from July to December 2017.

On the proposal of Cllr. Clarke, seconded by Cllr. Wallace, the list of grants were approved by the Members.

***Item 12 : Replies to Questions***

The Replies to Questions for June were noted and supplementary questions answered, as listed hereunder.
