I. Title and Interpretation

Westmeath County Council in exercise of the powers conferred them by Section 9 of the Road Traffic Act 2004 (No.44 of 2004), as amended, hereby make the following Bye Laws in respect of certain public roads laws in respect of the locations as listed below within the area comprising the administrative County of Westmeath.

1. These Bye-Laws may be cited as the Road Traffic (Special Speed Limits Housing Estates) Bye-Laws, 2016
2. These bye-laws shall come into operation on the 1st day of November 2016.
3. In these bye-laws:-

“the Act of 2004” means the Road Traffic Act, 2004 (No. 44 of 2004);

“the Act of 2014” means the Road Traffic Act, 2014 (No. 3 of 2014);

“housing estate” for the purpose of these Bye-Laws are considered to be self-contained groupings of houses with single or multiple entry points for vehicles or local residential roads that do not serve as through roads within the local road network. Such areas often have green areas or play areas associated with them.

“the Minister” means the Minister for Transport, Tourism and Sport;

“public road” means a road over which a public right of way exists and the responsibility for the maintenance of which lies with a road authority;

“maps” means the accompanying maps for each town or village and the surrounding public road network as detailed in Schedule 1.

Any words or terms used herein which are not specifically defined above shall have the meaning (if any) attributed to them in the Road Traffic Acts 1961 to 2014.

4. Thirty (30) Kilometres per hour shall be the special speed limit for mechanically propelled vehicles on the public roads of the housing estates specified in these bye-laws.
5. The provisions of any preceding Road Traffic (Special Speed Limits) (County Westmeath) Bye-Laws insofar as they apply to any of the roads or parts thereof referred to in the schedule to these Bye-Laws are hereby revoked from the date on which these Bye-laws come into effect.
6. There shall be exempted from the special speed limits prescribed at 5 above the following:-
 - (i) ambulance (as defined by Section 87 of the Act of 2014),
 - (ii) fire brigade vehicles (as defined by Section 87 of the Act of 2014),
 - (iii) vehicles used by members of the Garda Síochána in the performance of their duties as such members,
 - (iv) any vehicle subject to a speed limit as prescribed by the Minister pursuant to Section 4 of the Road Traffic Act 2004.

SCHEDULE 1

A special speed limit of Thirty (30) kilometres per hour is prescribed for all public roads within the following housing estates **and the surrounding public road network** as represented on the accompanying maps for each town or village in the list.
