

<b>Minutes of Meeting of Mullingar Municipal District held on Monday, 8<sup>th</sup> May, 2017, at 2.00pm in St.Joseph's Secondary School, Rochfortbridge.</b>

At the start of the meeting, the Mayor welcomed all and stated that this is a unique occasion in that it is the first time the Municipal District has held a meeting in a school. He welcomed the students from the Politics Class as well as their teachers and he thanked the school Principal, Eileen Alford for facilitating the meeting. He explained the Agenda and the format of the meeting to the students and the meeting then commenced.

***Item 1 : Miontuairisci***

- (i) On the proposal of Cllr.Glynn, seconded by Cllr.Clarke, the Minutes of April Meeting of Mullingar Municipal District held at 2.00pm on Monday, 10<sup>th</sup> April, 2017 in the Council Chambers, Áras an Chontae, Mullingar were unanimously approved.

**Matters arising:**

There were no matters arising from the Minutes.

***Item 2 : Update on proposed works at Main Street, Kilbeggan***

The Director of services updated Members on the works proposed for Main Street, Kilbeggan, following receipt of funding in the amount of €1,460,000. He circulated Members with a timeline for the proposed works which it is hoped will commence in June with a site survey, followed by design, which in turn will be followed by the Part 8 Planning Process. This Part 8 planning process is due to conclude at the end of November 2017 and following this, the construction period by direct labour will commence and will last for a period of 30 weeks.

The Members welcomed the proposed works for Kilbeggan. Cllr.McDaniel stated that works to the main street in Kilbeggan were promised when the M6 was finalised. Cllr.Penrose welcomed the fact that works would be carried out by direct labour. Cllr.Duncan hoped that parking along the street would not be reduced. Cllr.Clarke asked if the maps and proposals will be on view in Kilbeggan. The Director responded to the Members queries. He stated that all maps and documents under the Part 8 planning process would be displayed in Aras an Chontae in Mullingar and in the library in Kilbeggan. The Director explained the Part 8 planning process to the students.

***Item 3 : Update on Town and Village Renewal Programme***

The Director circulated the 2017 application form under the Town and Village Renewal Scheme to the Members. He advised Members that there are a number of changes to the process from last year and different criteria for how applications will be selected. He advised that the date of 12<sup>th</sup> May is the date for expressions of interest from interested community groups. An Evaluation Committee will be formed to examine the applications that come in and the Council's Community Development Section will assist community groups with their applications. He went on to state that this process is about enhancing the economic life of towns and villages and making these places a better place in which to live and work. The Director stated that grant applications have to be submitted to the Department by 30<sup>th</sup> June and he further advised that Members will be advised of the nature of applications which are being submitted for funding.
